CONDITIONS OF PARTICIPATION

Graphic designers, graphic artists, photographers, art associations, gallery owners, booksellers, book and print publishers and printing workshops who present a high-quality offering are warmly invited. Young artists are particularly welcome.

Serial graphics such as woodcuts, etchings, copper engravings, lithography, linocuts, screen printing, etc., old graphics (e.g. maps), art books, manuscript prints, catalogs and mixed media in the field of printmaking are permitted. Our profile does **not include** paintings, sculptures and mass prints (e.g. postcards).

Presentation, customer advice and sales are carried out by the participants themselves. The stalls must be set up by the start of the Graphic Arts Fair (Friday, 4 p.m.) and manned for the entire duration of the Graphic Arts Fair.

Illuminated stalls of approx. 4 x 1 m are available for participants. The hanging area is approx. 6 running meters. The partition walls of the stalls are approx. 2m high (can be fully used). Sales tables (approx. 200cm x 60cm) and chairs are also provided. You are welcome to bring your own clip lamps or spotlights. Power is available. Not every installation is possible and is expressly not guaranteed.

The stall fee amounts to 100 euros per stall. Only one stall is available for each exhibitor! Exhibitors will not be charged a sales commission.

APPLICATION

The application for participating in the Graphic Arts Fair together with information material must be submitted to the city of Borken by **November 30, 2026**. Applications can be submitted by post in paper form or digitally (see delivery address below).

The **jury** makes a decision based on the submitted applications about participating in the Graphic Arts Fair. It is therefore very important that meaningful materials such as a CV (max. 2 pages including exhibition directory, awards if applicable), prints (max. 6 originals or max. 6 copies/photos of the same) or catalogs (max. 3) are submitted. The information about the works, such as technique, title, dimensions, etc., must be complete.

Submissions on CD or USB stick are not possible.
We will send a cloud link via email upon request.

The admission conditions also apply to all those exhibitors, who have already been admitted to the Graphic Arts Fair in previous years. This is the only way the jury can get an accurate picture of the exhibitor's offering.
